The signatory parties have agreed the following:

Article 1 - Subject

- The Coordinator and the Co-beneficiary undertake to carry out the programme of the work which is the subject of the present Contract, within the framework of the Grant Agreement No. 2019-1-SE01-KA202-060482 signed between the Coordinator and the Swedish National Agency: The Swedish Agency for Higher Education/ Universitets- och högskolerådet, concerning the project: "Synergy Audit".
- The maximum grant of the project for the contractual period referred to by the Grant Agreement No. 2019-1-SE01-KA202-060482 is estimated at EURO 275 277 (inclusive all possible taxes). Under no circumstances may the financial aid provided result in a profit.
- This contract shall regulate relations between the parties, and their respective rights and
 obligations with regard to their participation in the project "Synergy Audit" under the Grant
 Agreement No. 2019-1-SE01-KA202-060482 passed between the Swedish National
 Agency: The Swedish Agency for Higher Education/ Universitets- och högskolerådet, and
 the Coordinator.

Article 2 - Duration

- The present Contract shall come into effect on the 1st of September 2019 for a period of 31 months and shall end on the 31st of March 2022.
- The period of eligibility of the costs starts on the 1st of September 2019 and finishes on the 31st of March 2022 at the latest.

Article 3 - Obligations of the Coordinator

The Coordinator shall undertake to:

- take all the steps necessary to prepare for, perform and correctly manage the work
 programme set out in this contract and in its annexes, in accordance with the objectives of
 the project as set out in the Grant Agreement concluded between the Swedish National
 Agency and the Coordinator;
- to notify and provide the co-beneficiary with any amendment made to the Grant Agreement No. 2019-1-SE01-KA202-060482 concluded with the Swedish National Agency;
- to comply with all the provisions of Grant Agreement No. 2019-1-SE01-KA202-060482 binding the Coordinator to the Swedish National Agency.

Article 4 - Obligations of the Co-beneficiary

The Co-beneficiary shall undertake to:

take all the steps necessary to prepare for, perform and correctly manage the work
programme set out in this contract and in its annexes, in accordance with the objectives of
the project as set out in the Grant Agreement No. 2019-1-SE01-KA202-060482 concluded
between the Swedish National Agency and the Coordinator;



- comply with all the provision of the Grant Agreement No. 2019-1-SE01-KA202-060482 binding the Coordinator to the Swedish National Agency;
- communicate to the Coordinator any information or document required by the latter that is necessary for the management of the project;
- accept responsibility for all information communicated to the Coordinator, including details
 of costs claimed and, where appropriate, ineligible expenses;
- define in conjunction with the Coordinator the role and rights and obligations of the two
 parties, including those concerning the attribution of the intellectual property rights.

Article 5 - Financing & Bank account details

- All payments shall be regarded as advances pending explicit approval by the Swedish National Agency of the final report including approval of the eligibility of the costs, the corresponding cost statement and the quality of the results of the project.
- The estimated maximum budget of Provincia di Parma will be € 31498, and the payment will be carried out directly from the coordinator. The budget will be distributed in accordance with a payment plan decided by The Swedish Agency for Higher Education/ Universitets-och högskolerådet and communicated to One Planet in August 2019 whom thereafter communicate the exact payment plan to each partner organization. One Planet will distribute the payments solidarity-wise between all partners throughout the project time. Meaning, if Synergy Audit will get the first 20% of the entire project budget in e.g. September 2019 it will lead to a payment from One Planet of 20% to each partner organization equal to 20% of the full budget of each partner.

Article 6 - Record Keeping and Reporting



- The Co-beneficiary shall provide the Coordinator with the documents necessary for the
 preparation of the "Progress report" no later than 45 days before the submission date of
 the report.
- The Co-beneficiary shall provide the Coordinator with the documents necessary for the
 preparation of the "Final report" no later than 60 days before the submission date of the
 report.
- The Co-beneficiary shall promptly inform the Coordinator of any delay in the performance
 of the activities undertaken by the Partner under the present contract.
- A Final Report on the Project activities, including a final Declaration of Expenditure must be submitted by the Co-beneficiary to the Coordinator no later than 20 days after the end of the period covered by the Grant Agreement.
- Upon request the Co-beneficiary shall make available any documentation on Project finance and activities required by the Swedish National Agency.
- The Co-beneficiary will provide a full report of the real expenditure accompanied by attested copies of invoices and receipts.
- The Co-beneficiary should keep the original documents for all expenses, made during the eligible period of the project, for a period of five years after the end of this project.

Article 7 - Monitoring & supervision

- The Co-beneficiary shall provide without delay the Coordinator with any information that
 the latter may request from him concerning the carrying out of the work programme covered
 by this contract.
- The Co-beneficiary shall make available to the Coordinator any document making it
 possible to check that the aforementioned work programme is being or has been carried
 out.

Article 8 - Visibility

The Co-beneficiary allows the Coordinator to publish information, data, and materials
regarding or produced by its organisation on the European platforms for dissemination and
valorisation as well as on the project's website.

Article 9 - Liability

- Each contracting party shall release the other from any civil liability in respect of damages
 resulting from the performance of this Contract, suffered by itself or by its personnel, to the
 extent that these damages are not due to the serious or intentional negligence of the other
 party or its personnel.
- The Co-beneficiary shall protect the Swedish National Agency, the Coordinator and
 their personnel against any action for damages suffered by third parties, including project
 personnel, as a result of the performance of this contract, to the extent that these damages
 are not due to the serious or intentional negligence of the Swedish National Agency, the
 Coordinator or their personnel.

Article 10 - Termination of the contract



- The Coordinator may terminate the contract if the Co-beneficiary has inadequately
 discharged or failed to discharge any of the contractual obligations, insofar as this is not due
 to force majeure, after notification of the Co-beneficiary by registered letter has remained
 without effect for one month.
- The Co-beneficiary shall immediately notify the Coordinator, supplying all relevant information, of any event likely to prejudice the performance of this contract.

Article 11 - Jurisdiction clause

- Failing amicable settlement, the Courts of the Coordinator's registered office shall have sole competence to rule on any dispute between the contracting parties in respect of this contract
- · The law applicable to this contract shall be the law of Sweden.

Article 12 - Amendments or additions to the contract

 Amendments to this contract shall be made only by a supplementary Contract signed on behalf of each of the parties by the signatories to this contract.
